Please mail your entry along with a check made payable to K9 Nose Works. **Entry deadline: May 31, 2009.** Mailing your entry is not a guarantee of participation in the trial. There are 24 entries available for NW1 and 6 for NW2, for a total of 30 competitors. Only teams who have achieved NW1 titles may enter NW2.

The first entries received along with payment will be assigned the available spots. You will receive an email confirmation that your entry was received. Once we receive your entry, you will be emailed notification of your entry status.
